



POLISH EDUCATION

HIGH QUALITY EDUCATION

Poland has a long history of higher education, and is well known for having 17 Nobel Prize winners, ranking 11th in the world for its number of Nobel Prizes. There are about 450 universities in Poland and there are many national and regional academic centres. The national education level is ranked as high. The majority of public universities offer programmes taught in English. In addition to the general public universities, there is a large number of professional institutes specialising in medicine, agriculture, technology, economics, music and art. These degrees obtained in Poland, are recognised worldwide.

CREDIT TRANSFER OR EXCHANGE WITHIN THE EU

According to recent data published by the Organisation for International Economic Co-operation and Development (OECD), Polish Education ranks 5th in Europe, 11th in the world, and one of the top in the Programme for International Student Assessment (PISA). As a member of the European Union, Poland also plays an important role in the Bologna Process. Thanks to the European Credit Transfer System (ECTS), diplomas obtained in Poland are widely recognised in Europe, and any credit obtained by international students at Polish higher education institutions are recognised by other countries around the world.



GREAT OPPORTUNITIES TO STUDY IN POLAND

LANGUAGE ADVANTAGE

There are more than four hundred registered universities in Poland, most of which offer courses in English. There is no need to learn Polish. Students also have the opportunity to learn and choose majors taught in Polish, German, French and Russian. After graduation, students can utilise their multilingual talent.

STUDY ABROAD COST IS VERY LOW

The tuition in Poland is about 60,000-80,000 RMB/year, meaning it is feasible to study at a total cost of less than 100,000 RMB/year including accommodation.

SAFE ENVIRONMENT

Poland has a stable social environment, which is friendly to those who immigrate there. Food choices are also delicious.

BEING IN THE SCHENGEN ZONE

Poland is a European Schengen country and also a member of the European Union. After studying in Poland for one or two years, students can apply for exchange programmes in other member states of the European Union, and they can go to European Schengen countries without a visa.



GREAT OPPORTUNITIES TO STUDY IN POLAND

ERASMUS MUNDUS

There are more than 100 cross-university scholarships and tens of thousands of visiting scholar places each year for European and non-European students. The degree obtained through this programme is recognised as the world's leading research university degree. The programme provides students with the opportunity to go on an exchange with another university in the EU, taking Poland as a window to experience EU higher education in more depth.

GOOD EMPLOYMENT PROSPECTS

Poland is a country with the most stable economy and the fastest development in Europe. It is also one of the most important strategic cooperation countries of China's One Belt And One Road initiative in Europe. The cultural trade between China and Poland is getting closer and closer, and there is a large demand for cross-cultural talent, which provides more job opportunities for Chinese graduates in Poland. International students can find jobs in Poland and all over Europe. After graduation, Chinese companies based in Poland and Europe have become the first choice for many students studying in Poland.




CHINESE INVESTMENTS IN POLAND AND THE EU

In 2019, 88.6% of China's ODI went to Asia and Europe, of which \$10.52 billion went to Europe, up 59.6% year on year.

In October 2020, data released by Eurostat showed that in the first seven months of 2020, the total import and export volume between the 27 EU member states and China was 328.7 billion euros, up about 2.6% year on year. According to China's Ministry of Commerce, the trade volume between China and the EU grew by 4.9% in 2020 to reach \$649.5 billion, making China the EU's largest trading partner for the first time.

With the signing of the China-EU Investment Agreement, EU companies will benefit from fairer treatment in the Chinese market. The 17 EU member states in Central and Eastern Europe, such as Poland, Czech Republic, Hungary, Slovakia and Bulgaria, will directly benefit from the China-EU Investment Agreement and drive the growth of bilateral trade.

Despite the severe impact of the pandemic on the global economy, economic and trade exchanges between CEE countries and China have been on the rise. In 2020, China-Europe freight trains will deliver 1.35 million TEU, up 56% year on year, and the combined heavy container rate will reach 98.4% in Poland, Hungary, the Czech Republic and Lithuania. Slovakia and other CEE countries have become important passageways and destinations for China-Europe freight trains, and cooperation between China and CEE countries has improved.

The University of Cardinal Stefan Wyszynski (UKSW) was founded in 1999 as a national institution under the direct administration of the Polish Ministry of Education, with the approval of the Polish Parliament. Its roots come from the Jagiellonian University in, Cracow, Poland, one of the oldest universities in Europe, established in 1364 and Warsaw University, established in 1816. The newly established UKSW University inherits the long history and culture of the old state universities and is developing rapidly. Its style is both traditional and modern, and it has become one of the most popular and chosen public universities by students.

THE MOST POPULAR AND CHOSEN COMPREHENSIVE NATIONAL UNIVERSITY IN POLAND


There are two campuses in UKSW, with 12 faculties and 32 fields of study, for example, the humanities and natural sciences includes the Faculty of Philosophy, History and Social Sciences, Law and Administration; Humanities; Theology; and Family Studies; while other options include Mathematics and Natural Sciences, Biological and Environmental Sciences, Education and others. Students can choose a wide range of degree courses. Every field of study includes a bachelor's degree and a master's degree. UKSW also has the right to grant doctorates in 12 subjects: Law, Philosophy, Psychology, History, Sociology, Political Science, Literature, Mathematics, Pedagogy, Physics, Theological Church Law; and six disciplines for postdoctoral degrees: Psychology, History, Sociology, Theological Canon Law and Philosophy. UKSW professors are well known in Polish and world-wide academia.

FACULTY OF LAW AND ADMINISTRATION

One of the 12 faculties in UKSW. It is also one of the most famous law schools in Poland and is renowned in Europe. The faculty consists of 29 departments, including the Department of State and Legal History, the Department of Administrative Sciences, the Department of Environmental Protection, the Department of Civil Law and Private International Law, the Department of Financial Law and Economics, the Department of International Relations, and the Department of International and European Law. The Programme on Entrepreneurship and International Relations is under the Institute of Law, the faculty of Law and Administration.





There are more than one hundred scholars and teachers employed. Among them, there are experts who are present or were formerly Commissioners for Civil Rights Protection; judges of courts of the European Union, the Constitutional Tribunal, the Supreme Administrative Court, and Supreme Court; members of the Legislative Council of the Prime Minister, Parliament, Senate and Polish Republic President's experts, lawyers, counsellors of law, public prosecutors, ambassadors, central agency employees especially from the Ministry of Foreign Affairs and the Ministry of Justice.

The curriculum of the department of International Relations brings all major aspects of contemporary international relations together in Europe and the world: politics, society, economy, culture, law and, state and international security. The research work focuses on the reflection of the integral heritage of human knowledge, faithfulness to the truth and values as a source of inspiration. The conducted research is based on the essence and functioning of law in various fields, on the role and tasks of modern administration (national and international) and on international relations in particular with Europe and The United States of America. The department's research is based on a wide scale upon the European and International aspects of of law, along with the input of the domestic aspects of law.




STEP 2: ENTREPRENEURSHIP AND INTERNATIONAL RELATIONS STUDY PROGRAMMES IN ENGLISH





THE AIM OF THIS BACHELOR'S PROGRAMME IS TO TRAIN MULTILINGUAL AND MULTICULTURAL HIGH-QUALITY PROFESSIONALS FOR TRANSNATIONAL CORPORATIONS, NATIONAL ADMINISTRATIVE DEPARTMENTS, EUROPEAN UNION ADMINISTRATIVE DEPARTMENTS AND INTERNATIONAL ORGANISATIONS.





BACHELOR'S DEGREE IN ENTREPRENEURSHIP & INTERNATIONAL RELATIONS + EMPLOYMENT IN THE EUROPEAN UNION OR BRITISH COMPANIES

Undergraduate students will be offered comprehensive training, and develop their understanding of business problems in an international environment. Students will be introduced to international law, international policies and economics, international relations, company law and development, and negotiation skills in a foreign language. Students will gain knowledge in the management and development of different types of business entities. This will help them to get a job in international public enterprises and local governments as well as develop their own businesses.

UKSW has a dedicated business incubator project to provide guidance and resource allocation for graduates and students to start their own businesses and incubate enterprises. UKSW can also recommend good internship opportunities for students in institutions and commercial enterprises.

The main areas focused on in these courses are:

- 1. Public International Law, including International Economic Law
- 2. The Economic Law of the European Union
- 3. International Private Law
- 4. International Political and Economic Relations
- 5. International Negotiations
- 6. Establishing, Managing and Developing Different Types of Business Entities

MA IN ENTREPRENEURSHIP & INTERNATIONAL RELATIONS - PROFESSIONAL QUALIFICATION, EMPLOYMENT IN INTERNATIONAL ORGANISATIONS OR TRANSNATIONAL CORPORATIONS

A graduate has the option of working in transnational companies developing international business, working within public administration, in international organisations and institutions, or in establishing their own business.


There are two main modules in the field of Entrepreneurship and International Relations:

Module One: International Organisations - Study and research on the administration and management of global international institutions such as the EU, WTO and European security

Module Two: Transnational Corporations - Study and research on the actual business development of state-owned or private enterprise groups in various large transnational financial and commercial backgrounds, trades, logistics and other fields

UKSW has a dedicated business incubator project to provide guidance and resource allocation for graduates and students to start their own businesses and incubate enterprises. UKSW can also recommend good internship opportunities for students in institutions and commercial enterprises.

On conclusion of the programme, the graduates makes a decision regarding their career, which is supported by the university's contacts and cooperation with different state and business entities.



STEP 3: ENTREPRENEURSHIP AND EMPLOYMENT OPPORTUNITIES

Undergraduates from the Entrepreneurship and International Relations department have working knowledge of international law and international organisations, a full understanding of the socio-economic and political conditions of international relations, and an indepth study of the relations between different regions.

3-YEAR BACHELOR: ENTREPRENEURSHIP AND INTERNATIONAL RELATIONS

After completing the 3-year Bachelor in Entrepreneurship and International Relations, a graduate is prepared to work as a junior specialist in a private business or public administrative role. The graduate is also prepared to continue to the Master's in Entrepreneurship and International Relations on completion of their Bachelor's.

2-YEAR MASTER STUDIES: TRANSNATIONAL CORPORATIONS

After completing the 2-year Master Studies specialising in the field of Transnational Corporations, the graduate is prepared to work in private and state enterprises, planning international business development and creating the infrastructure supporting European and Asian state and private companies. Moreover, graduates of the Master's in Entrepreneurship and International Relations are employed by Polish financial networks such as banks, insurance companies, the Polish Development Fund, the Polish Agency of Enterprise Development, the National Holding Bank, the Banking Indemnity Fund, and chambers of commerce.

2-YEAR MA: THE "INTERNATIONAL ORGANISATIONS" MODULE

After completing the 2-year MA, the "International Organisations" module, the student is prepared to take official examinations in international organisations and work in such organisations. Students can progress to working with bodies including the European Union, the International Labour Organisation, the Organisation for Security and Co-operation in Europe, and the World Trade Organisation



9 ADVANTAGES OF THE PROGRAMME

- 1. The foundation programme is delivered at the high-quality comprehensive national university which connects bachelor's and master's degree programmes. The Entrepreneurship and International Relations Programme is a green path from university to employment abroad.
- 2. The Gaokao (Chinese National Exam) grade is not required. Students who have attended Chinese high school with English grades are admitted to public universities in European Union states and this also refers to the Entrepreneurship and International Relations Programme, which is offered after completing the Foundation Programme.
- 3. The studies are in English, and students also gain the ability to communicate in Polish, other European languages are optional. Students will have a multilingual talent on their graduation.
- 4. The diplomas are accredited by the Ministry of Education in China and the European Union. Moreover UKSW's qualifications have global recognition.
- 5. Poland is a key strategic cooperative country under the Chinese One Belt and One Road Initiative, the fastest developing country in Central and Eastern Europe, and a country with one of the highest employment rates in Europe. There are more opportunities for talent with multiple languages, academic and professional backgrounds.



- 6. Safe environment at the university campus and in the city. The cost of living and personal expenses are much lower than in the UK, the USA and most of the EU tuition and living costs are about 100,000 yuan per year.
- 7. It is the first choice for students from an average family.
- 8. Getting an offer from the National University will ease the process in getting a Visa.
- 9. The UKSW provides campus accommodation with good conditions within the tuition price for the Foundation Programme and First Year Undergraduate Students. Students are offered support with their student visa process and extension while studying at the university. Students are also collected from the airport after arriving to Poland and introduced to the campus, university and living in the city.
